This Legislative Update Contains the Following Categories:

- Bills that VACSB is following that have passed. (This includes the bills that the governor made amendments to and then the general assembly passed those bills, with the governor's amendments, during the reconvened session. These bills are now waiting on the governor's signature. It is unlikely that the governor will veto these bills. The details of these bills are directly below.)
- FYI bills from the regular session and special session that have passed
- FYI bills from the regular session that have died
- FYI bills from the special session that have died

The House and the Senate Concurred on the Governor's Recommendations to the Following Bills:

1. Marijuana Legalization: [HB2312](#) – Herring & [SB1406](#) - Ebbin / Lucas

Recommendation made by the governor will do the following:

- Move the legalization of simple possession and home cultivation for ages 21 and over from January 2024 to July 1, 2021. Legalization of retail sales will still be January 2024.
- Allow for expungement and sealing of criminal records on former marijuana offenses to begin as soon as state agencies are able to do so. This amendment should speed up the process. The original deadline was July 1, 2025.
- Simplify the criteria for when records can be sealed.

Governor's budget amendments (12 & 14) ([HERE](#)) related to marijuana legalization

- \$1M in training for law enforcement for detection and enforcement of "driving under the influence."
- \$1M in marijuana prevention and education programs and public health campaigns.

Provisions that are still in the marijuana bills that did not change:

- January 1, 2024 retail sales of marijuana becomes legal
- 25% from income to the state will go toward SUD and Prevention: *DBHDS, which shall distribute such appropriated funds to community services boards for the purpose of administering substance use disorder prevention and treatment programs.*
- Advisory council to the advisory board will be established. One CSB representative will be on this council.
- The licensing board may refuse to grant licenses for retail near SUD treatment facilities.
- No outdoor retail marijuana or retail marijuana products advertising shall be placed within 1,000 ft. on the same side of the road, and parallel to such road, measured from the nearest edge of the sign face upon which the advertisement is placed to the nearest edge of a building or structure located on the property of (i) a public, private, or parochial school or an institution of higher education; (ii) a public or private playground or similar recreational or child-centered facility; or (iii) a **substance use disorder treatment facility**

2. Consideration of mental condition and intellectual and developmental disabilities during criminal proceedings: HB2047 - Bourne & SB1315 – McClellan

- Previously DD and MH had not been admissible in court. Insanity was the only category. Defense was not allowed to present MH or DD as evidence.
- The bill started out as just adding DD. MH was added to the bill during GA session. By adding MH, language was added that would allow judge to issue a TDO from the bench.
- The governor's recommendation was to replace the TDO language with ECO language. The house and senate concurred on this.
